




#### FROM THE PASTOR

Recently I was teasing a member of the Pastor Nominating Committee, aka the Leonard replacement committee, as to what my legacy would be. (I hasten to add I am supposed to be replaced - my role is to get you ready for your next pastor!) Much to my disappointment, it was not, he shepherded a successful New Beginnings Process, or he showed us another way of being a pastor. Instead, she said I would be forever known as the "covid pastor". Sadly Liz Bonisteel was right. Coping with this global pandemic has put an indelible mark on my time here and especially so this last year.

I am pleased with how well we have muddled through. I remember taking a pencil and a blank piece of paper and drafting the questions we would ask on our entrance sign-in sheets. None of us had any preparation for this! Nevertheless, worship continued, missions such as our Prayer Wall and funding for the Urban Mission, among other things, remained consistent. We also managed to offer some programming and remained focused on our New Beginnings process, and even started a Pastor Nominating Committee.

2020 was covid, covid, yet we remained an outpost of God's grace!

All that would not have happened were it not for members of the congregation stepping up and doing more than they had in the past. In particular, I want to name Dave Elmer because describing some of what he did and how he and I worked together will help me make a point. Dave worked hard figuring out how to do some new things, but mostly how to do the same old things in a different way. This may surprise you, but there was more than one occasion when Dave and I had to apologize to each other and ask for forgiveness. What made that possible besides simple regard for each other was the constant awareness that what we were doing (worship and Zoom technology) really mattered. There were many others in this congregation that knew that maintaining the ministry here mattered. You know who you are. Thank you!

Finally, I want to tell you what the best and most hopeful thing that happened at the church in 2020. Recently, we have begun distributing hats, scarves, and mittens from the front steps of the church. Of course, it is a necessary and wonderful thing to do. Here is how it came about: Towards the end of a regular Deacon's meeting, someone wondered aloud about if we were still doing a mitten tree this year. Because foot traffic in the Fellowship Hall has been reduced by, say, 95%, our regular way of gathering hats, scarves, and mittens for distribution was unavailable to us. What happened next was in less then (15) minutes, the plan to put them outside for the taking was created. A dozen or so detailed decisions were made in seconds. It was the best (15) minutes of 2020. In my (21) months here I have participated in meeting after meeting where we worried something to death. That Deacon's meeting, I witnessed a new form of ministry being created in minutes, without a vote or even the approval of the Session.

It is clear to me that in 2020 you became more capable of doing ministry. I am grateful to be sharing part of your journey.

#### NEW BEGINNINGS STEERING COMMITTEE

The Session approved the formation of the New Beginnings Steering Committee in November 2019 as a continuation of the process of self-assessment that began with cottage meetings held that summer and fall. Over one hundred members and friends of the congregation participated in those discussions, and the consensus was a desire to move toward becoming a discipleship-focused church. The committee was tasked with carrying out the logistics of that process. Meetings were held throughout 2020 to research and understand our church and community, and to discern the necessary steps to take to become a more vibrant congregation. Three themes emerged quite clearly: the need for discipleship with faith, a desire for worship with participation, and a goal of mission with relationship.

In October the steering committee presented initiatives to the Session regarding all three themes:

- 1) To develop a new series of cottage meetings designed to nurture our faith and support a foundation for living as disciples.
- 2) To broaden participation in worship, and specifically to create a pilot for an additional, alternative, version of our traditional worship service.
- 3) To create a short-term opportunity to welcome the community through an activity or event in the church building or on the grounds, and to begin planning for a connection with the community through an on-going activity based at the church when access is appropriate.

The Session continues to guide implementation of the initiatives using the resources of existing committees and boards, while the Steering Committee will meet at least quarterly and will provide support and share additional recommendations to those committees and boards as they put these ideas into action.

#### PASTOR NOMINATING COMMITTEE

The Pastor Nominating Committee (PNC) tasked with identifying our new pastor for First Presbyterian was formed in mid October of 2020. The following individuals comprise the committee:

David Elmer and Liz Bonisteel volunteered to co-chair the committee and Michele Bariteau volunteered to be our recording secretary. Our first meeting took place on October 15 and involved a preview of the process with our Resource Presbyter, Rev David Bennett.

The initial task of the committee was to complete a Ministry Information Form (MIF), which is a standard form that is used to provide a description of the characteristics that we are seeking in our next pastor. In effect, this is our job description. We were required to select ten desired characteristics from a list of 33 options. We then answered 5 narrative questions which allowed us to both describe our congregation and further clarify what we are looking for in our pastor. We have been meeting approximately weekly for the past two months with a mix of in-person and on-line attendance. We have relied heavily on the insights gained from our New Beginnings experience to guide us in this process. As a group we also have well over 100 years of personal experience in this church. At the time of this writing (1/24/21) we are finalizing the MIF. It now must be reviewed by our Resource Presbyter and our Session, and then approved by the Committee on Ministry of the presbytery.

The next step is to submit our completed MIF to the Church Leadership Connection (CLC) which is an electronic database which will identify pastor candidates who seem to match the desired characteristics for our position. We will then start the process of reviewing the Personal Information Forms (PIFs) of these candidates to narrow our search. Your PNC hopes to have a reasonable number of candidates to review and discuss within the next two to three months. I anticipate some lively discussions as we try to select the most appropriate individuals for interviews.

This process is open ended, and none of us know how long it will take to identify the individual that we will call as our next pastor. If we are truly blessed, we may be able to report a successful search and the dissolution of the PNC for next year's annual report. But we know that there are many possible reasons for delay. We will continue to open each meeting with prayers seeking guidance, and close each meeting with prayers of thanksgiving and hope. We rely on the congregation for their prayerful support.

#### THE ENDOWMENT FUND

#### The Endowment Fund

The endowment of the First Presbyterian Church is \$6,527,810. The fund's value gained \$370,021 or 6% in 2020. At the same time the endowment provided the church an income of \$290,268.

The church's endowment weathered the storms in the capital markets during 2020. The equity return (net of all fees) exceeded our benchmarks. Our bond account returns lagged the overall market results.

During the second and third quarter of the year the committee developed a new investment policy to reflect changes in the financial markets and provide a clear direction forward for management of the church's financial assets. The session has adopted the guidelines.

In October the endowment committee reduced the endowment's exposure to equities by taking \$200,000 equities to be used to fund the capital projects that the church has completed or has underway. The committee reviews the allocation of assets between bonds and equities periodically to reduce the impact of sharp market declines. Such transfers however may restrain growth during period of sharp increases in equity values.

At year end the endowment consisted of 68% equities and 32% bonds. The investment policy of the church calls for an investment range of 55% to 65% equities and the balance in bonds.

The endowment committee will monitor the investment allocation as the year develops.

The positive 2.47% performance of the bond account was below its benchmark -the Barclays Capital Index which grew 4.71%. The return on the equity account at
Morgan Stanley was 25.27% exceeding the S & P Total Return Index of 18.4%. Anchor
Capital's return of .54% was well below its benchmark of The Russell Mid 4.96%,
Estabrook's return of 8.01% lagged the Dow Jones and S &P 500 returns of 9.72 and
18.4% respectively. However these two benchmarks were restructured in 2020 and the
comparison to the Estabrook account may no longer be relevant.

The income paid to the church represented 5.0% of the average value of the endowment for the previous three years. The Session has reduced the dependence of the church on the endowment over the several years by setting a goal for the spending rate at 5%

#### **STEWARDSHIP**

Our committee established a goal of obtaining \$235,000 in pledges for 2021. Our goal reflects the reality that several of our most generous supporters at First Presbyterian Church are no longer with us. Some have passed away, some have moved away and some have chosen to no longer be part of our church family. Our goal also reflects the reality that many of our families have experienced significant hardships associated with Covid-19.

Having said that, I am pleased to report that our congregation continues to show a very strong and generous commitment to First Presbyterian Church.

As of January 16th, we have received pledge cards totaling \$225,785. We have verbal commitments from congregants for approximately \$10,000 and expect to receive those pledge cards in the near future. This will bring the pledge amount to approximately \$235,000.

There are still nearly 20 members of our congregation who submitted pledge cards last year but have not yet provided their 2021 pledges. We continue to reach out to these individuals and families with phone calls and letters, and we hope that their personal circumstances allow for the continued support of our church.

#### MEMBERSHIP/DISCIPLESHIP

The Discipleship/Membership Committee did not officially meet during 2020 because of the COVID-19 pandemic. Although increasing membership, maintaining accurate membership rolls and organizing a church directory remain important duties of the committee, the committee's primary focus has shifted to nurturing discipleship as individuals and as a congregation. The committee is dedicated to spearheading activities that are driven by one of the three initiatives from the New Beginnings steering committee: DISCIPLESHIP with FAITH. #### **EVANGELISM AND COMMUNITY PRESENCE**

This is a new committee for First Presbyterian Church. Our group engaged in stimulating conversation and came up with multiple excellent ideas. Opportunities for the implementation of these ideas should materialize during 2021 as the health concerns and risk of COVID-19 diminish.

The fundamental principle from which we operate is that we must give more people in our community, especially young people and young families, reasons to come to and be part of First Presbyterian Church, specifically reasons that make our Church meaningful in their lives.

Initiatives to be explored in 2021 include re-instituting our vacation Bible school, evaluating the viability of reestablishing a nursery school within our church building, establishing a booth at the weekly farmers market, offering parking passes to young parents during the farmers market and having fellowship hall open for a cool and comfortable place to rest, have lunch, have access to clean restrooms, changing tables and other amenities for young families.

We will also further discuss the possibility of a childcare program within our church.

Our group spent considerable time learning about an organization called the Fellowship of Christian Athletes. This is a multi-denominational Christian organization that leverages our society's profound enthusiasm for sports as an opportunity to promote traditional Christian values. Last November, the Session unanimously voted to facilitate the development of a Fellowship of Christian Athletes chapter in the Watertown area.

Finally, during 2021 our group would like to evaluate the average historical expenditure for advertising for First Presbyterian Church. Our goal is to explore various venues of advertising including Christian radio, take advantage of potentially free advertising as public service announcements and to explore the newspaper, Facebook and other types of promotion.

We see all our activities as opportunities to assist and promote the fundamental changes and enhancements to our worship services as outlined through the *New Beginnings Program*.

#### **FACILITIES**

The facilities committee is responsible for the general cleanliness, maintenance and project planning of the building and campus.

The year 2020 proved to be much different with building use. Our sexton was able to accomplish extra cleaning, painting, and organizing due to the limited use of outside groups. Automatic towel dispensers have been installed in all bathrooms and a cleaning and disinfecting schedule has been put in place to comply with COVID 19 regulations.

It has been determined that there was need for more security measures for the Christian Education wing and because of this, we have added key entries to certain areas. Room numbers have been reassigned for more current use and identification. MELT was granted its own more spacious room on the second floor.

The handicap ramp and entrance to the CE wing was pressure washed and stained this summer and the garbage corral was rebuilt. The largest project was replacing the entire roof for the whole building. The \$225,000. effort included metal roofs where needed and adding gutters at entry areas. We were able to offset the cost with an insurance claim of \$85,000. due to wind damage.

Three major projects for 2021 are as follows:

- 1) replacing our present 50+ year heating system with a new one that will include asbestos abatement and air quality testing, cost approximately \$300,000.
- 2) repair and paint the steeple and bell tower with bids in for up to \$50,000.
- 3) to finish painting our exterior at the cost of approximately \$40,000.

There also is concern at this time that the cellar windows will need attention. These tasks will round out almost all of our major endeavors.

Two matching benches have been separately donated for placement around the labyrinth. They will need to be secured in place once the weather allows

On a positive note, we were able to get an Energy Savings Plan from National Grid to update lighting throughout the building. The total job cost was \$6,300. of which we were only responsible for ten percent (\$630.00).

#### **WORSHIP & MUSIC**

The Worship and Music committee is responsible for overseeing the spoken word and music for Sunday services, weddings, funerals, and special services. Special services include Ash Wednesday, Maundy Thursday, Palm Sunday, Easter Sunday, Pentecost Sunday, Kirkin' o' the Tartan, The Christmas Pageant, and Christmas Eve.

Along with overseeing worship services, the committee prepares the Communion Elements, provides sanctuary décor, oversees radio ministry and sound enhancement. They provide assignment lists for Ushers, Lay Readers, and Communion servers.

Music events include: Music Sunday where we recognize more than 45 musicians who provide lovely sounds of music throughout the year; a Christmas Cantata offered by our Chancel Choir, Sunday School children, and members of the congregation; a brass quintet for services such as Easter and Christmas Eve services; the bagpipes for Kirkin' O' the Tartan; handbell choirs both adult and youth; and selections played by the Trillium Trio throughout the year. During the summer, music is provided by several talented musicians.

Covid-19 has created some unique opportunities. The music staff and committee have been creative with programming to maintain a full service each week and have provided special services when in-person attendance was not advised. The sound and video systems have been upgraded accommodating a higher quality broadcast and creating a sense of normalcy for those not able to attend services in-person. Thank you to Cassandra and Melissa Elmer for their long hours and dedication to make these changes possible.

I would like to thank all the volunteers that offer their time and talents to provide this congregation with spiritually uplifting services.

#### **CHRISTIAN EDUCATION**

The year began with the research into and purchase of a new laptop to serve the Christian education programs at First Presbyterian in January. Little did we know how fortunate we were, as this proved to be a valuable tool for many church programs during the pandemic. We also set up an email address for the Christian education program.

During our annual Lenten series, we also experimented with streaming live to our church Facebook page, as people were starting to stay home. Unfortunately, the outbreak of the pandemic resulted in cancellation of the series. We turned to educating our session members, staff and others on how to use Zoom technology to stay in touch for meetings and eventually Bible studies.

With the suspension of in person worship and the closing of our building, we also discontinued Sunday school classes. We provided online access to the Dig In curriculum for our parents instead. We rejoiced when we were able to resume Sunday school in the fall. Thank you to our sexton Mitch Farney for getting old desks out of the attic and cleaning them. This allowed us to implement social distancing in our classroom space.

We presented an online Bible study through our webpage in case Zoom technology was not available to some church members. This was a study of the apostle Paul by Dr. Ralph Wilson. It offered both text and audio for people to listen, as well as a series of questions.

We were able to utilize Zoom for adult education for the books Half Truths, What Christianity is Not, The Shelter of God's Promises. We thank Rev. Sponaugle for leading our discussion. For our Advent series Its a Wonderful (Virtual) Life in December, we organized two groups to watch the classic film via Zoom and discuss how it illustrated Biblical truths on the value of people, and how we are to treat others. Many thanks to our leaders Michele Elmer and Bunny Gorman.

Our annual Christmas pageant was unable to include live actors, so Michele Elmer wrote a beautiful narrative and created props for our nativity scene. The story still touches our hearts no matter how we adapt in the way we present it.

As part of a churchwide cleaning and sorting process, we installed additional shelving in our Christian education storage room. Michele Elmer and Donna Dunkle did a great job of organizing this space.

The Women of Grace Widows Fund has been working with 45 widows in 3 villages in northern Malawi since 2008. The fund has helped the widows establish some small businesses (selling charcoal, raising chickens and pigs) and has provided training in sewing, allowing the widows to earn money making PantiPlus menstrual hygiene kits, which are donated to local, needy teen girls. A win-win for the community!

The Watertown Board works closely with Grace Chiumia and Sam Chirwa in Malawi. Although Grace has had significant health challenges, Sam continues to provide "boots on the ground" recommendations about short and long-term needs. He ensures that donations are used most effectively for housing improvements and critical needs.

The Women of Grace newsletter is printed annually and contains many photos and articles which show the joys and challenges faced by the widows and the Women of Grace Widows Fund. It is available at the church.

Travel to Malawi has not been possible this year due to Covid, but the board plans to send a missionary team once travel advisories are lifted.

We sincerely appreciate the strong, prayerful support that the Women of Grace Fund continues to receive from individuals and congregations across the presbytery. We are truly grateful for the consistent support of the Session at First Presbyterian Church, particularly the allocation of the Christmas Eve Offering, which helps us meet the needs of the widows under our care.

Exciting news— the M.E.L.T. Central Library in Mzuzu, Malawi is open and serving 20 schools in the Northern Region. We broke ground in December 2019 in this three-phase project. The \$49,400.00 building was complete in August 2021. This is nothing short of a miracle during this time of a world pandemic. We thank First Presbyterian Outreach Council for their generous support as well as many members of this congregation. Our donors come from all comers of the country each showing their support in this important mission. We are proud to represent First Presbyterian in this discipleship work.

<u>Simple Words</u> Kits - This early literacy kit was designed with our teachers at our last meeting in Malawi at their request. All kits have been sponsored by individuals and groups. Ten were sponsored by DKG. These have been printed and will be the focus on our next trip.

<u>Rotary</u> – M.E.L.T. received a grant in December for 2021. This funds building shelves, big book racks, tables, chairs, administrative desk, floor and window coverings as well as publishing two new books (1,000 books). We thank the Watertown: Sunrise, Noon, Evening; and Clayton Rotary who partnered with Mzuzu Rotary!

<u>Relationships</u> - We have been able to remain in touch with our teachers even though we were not able to make a trip to Malawi in 2020. I have even been able to speak with a few teachers during Sam's visit via the international phone app - Whats App. A meeting was held recently that included many of our teachers - a meeting they wanted to hold - following protocol to come together to share ideas, hear concerns, and support one another. This made all of us feel very comforted that they took this upon themselves in our absence.

<u>Prayers</u> - We appreciate your prayers for our continued work with the teachers and students of Malawi. We have worked hard to build strong relationships in this mission. All schools we serve are in the Presbyterian Synod of Livingstonia.

#### SHALLOW WELLS REPORT

#### FPC raises \$7,970 that supports 18 protected shallow wells in Malawi!

Each year, since 2007, you have responded with benevolence in supporting our partnership with Presbyterian USA Marian Medical Mission's Shallow (MMM) Protected Shallow Well Program in Malawi, Tanzania and Zambia. THANKYOU!

100% of all of your donations go towards covering the installation of a protected shallow well that provides clean water for the first time to a village of around 150 people. MMM provides us a photograph of each village and well with each donation of \$450. MMM is a Presbyterian, ecumenical, Christian, front-line, hands on, American volunteer, non-profit driven organization. MMM's purpose is to share the love of Jesus Christ with the extreme poor in Africa thru protected shallow wells. It is a wonderful message to also share in 2020 that our FPC donations since 2007 now total over \$100,000 and represent 300 protected wells. What a wonderful legacy.

Over its 35-year history, Marion Medical Mission has created a unique infrastructure in Africa that is now 40,000 protected and maintained water wells in remote villages. The key component of this system is the 20 field officers serving the MMM network. Normally, about 40 US Volunteers work with these field officers to install the protected shallow wells each year that replace open contaminated water sources in Malawi. This year, our American volunteers were unable to travel to Africa due to the pandemic. However, Malawian counterparts installed 3,155 wells, benefiting nearly 400,000 people, covering roughly 60,000 square miles of terrain. Each well also represents self-help. Each village makes the bricks, digs the well, gathers the sand and stone and provides the unskilled labor. A Marion Medical Mission well is one that utilizes the talents of the Malawians. Other Malawians, properly trained, make the steel pumps, the PVC foot valves and plungers.

We at FPC are part of this team. The story includes us. All of us together make a difference to our unknown brothers and sisters. Your gifts matter! Share in the joy that you have aided your fellow men, women and children well beyond your imagination.

- provided financial assistance to the VAC, in Sept, and to the CAC, in December for Christmas presents.

# A RECORD of the 217<sup>TH</sup> ANNUAL MEETING of the CONGREGATION of FIRST PRESBYTERIAN CHURCH, WATERTOWN, NY on JANUARY 26, 2020 in FELLOWSHIP HALL

The meeting, which followed lunch, was opened at 11:30 a.m. with prayer by the Reverend Leonard Sponaugle.

The clerk determined that a quorum was present; approximately 70 members were in attendance, which exceeded the number needed for a quorum (approx. 30).

The minutes of the January 27, 2019 Annual Congregational Meeting were unanimously approved as written (Motion by Bob Gorman/Seconded by Jim Kettrick).

#### **WRITTEN REPORTS:**

Rev. Sponaugle presented the written reports (published in the Annual Meeting booklet) from Stewardship, Membership, Facilities, Worship & Music, Christian Education, Outreach, Missions, Personnel (presented by Donna Dayger), Deacons, Presbyterian Women, Radio Ministry, Prayer Chain, Flower Committee, and Parish Outreach Coordinator Linya Bell. There was time allowed for comments and questions; all reports were well-received and accepted as information.

Treasurer Merle Tousant gave a brief presentation of the financial summary, year-end 2019 budget (including personnel expenditures), and the 2020 Budget which was approved by the Session at its December meeting. Actual expenses for 2019 came in at almost \$80K under budget, mostly because of decreased payroll expenses. The 2020 Budget is anticipating an income of approximately \$642K and expenses of approximately \$614K, a difference of approximately \$28K surplus. There was time allowed for comments and questions; the financial report was received and accepted as information.

Rev. Sponaugle presented his pastor's report. Highlights included how he views his role of Transitional Pastor, the various "seasons" the church has gone through, including our present season of preparing to call our next pastor, excitement about the New Beginnings process, and advice regarding timing, managing energy levels, and coping with some major building repairs. He assured the congregation that he will "keep the lights on," shepherd the New Beginnings process, and help manage the large projects; at the same time, he will see to it that we are able to do all of the necessary tasks to get ready to call our next pastor.

At 11:49, the congregational meeting was adjourned and transitioned to the corporate meeting. The corporate meeting was opened with prayer by Rev. Sponaugle. John B. Johnson, Jr., Chair of the Endowment Committee, reported that the endowment of the First Presbyterian Church is \$6,157,789. During 2019 the fund's value increased \$859,129 or 16%; in addition, the endowment provided an income of \$244,341 to First Presbyterian Church. The Session continues to work toward reducing the dependence of the church on the endowment; currently it is at 5% of the average value of the endowment; the goal is 4.5%. Until that goal is reached, the increased spending of .5% continues to be a drag on the assets of the endowment.

Rev. Sponaugle, on a voice vote, closed the corporate meeting at 11:51 and reopened the congregational meeting.

Clerk of Session Bunny Gorman, chair of the Nominating Committee, updated the Nominating Committee report in the Annual Meeting booklet and the last page listing officers by their respective classes. She then presented the slate of officers for the **Class of 2023**: For the **Session**: Bunny Gorman (2<sup>nd</sup> term), Merle Tousant (2<sup>nd</sup> term), David Elmer, Deanna Nelson and

Matt Willaman; for the **Deacons**: Sherri Bergman (2<sup>nd</sup> term), Becky Brown, Donna Dunkle, John Gleason, Christina McDonald and Josh Garry. Also presented were: for the **Session**: Jonathan White (**Class of 2022** - two year term); for the **Deacons**—Sue Kitto (**Class of 2021** - one year term). The floor was opened for nominations. The Clerk informed the congregation that there is a one year term to be filled on the **Session** (**Class of 2021**), and there was a nomination, Kim Collins, from the floor to fill the one year term; there were no other nominations. There was a motion and a second to close the nominations.

The congregation voted unanimously to accept the slate of nominations.

The congregation then took names to form a Nominating Committee for the upcoming year. Bob Blank, Polly Blank, Jim Kettrick and Richard Lake were nominated from the floor. There were no other volunteers or nominations; a motion was made and seconded to close the nominations; the slate was approved unanimously.

There was a question and some discussion regarding church security. The Facilities Committee is developing and implementing a plan to enhance building security (i.e. locking certain doors; reactivating the intercom system) in order to keep worshippers and staff safe and secure.

There being no further pressing business, there was a motion, a second and a unanimous vote to adjourn the meeting with prayer by Rev. Sponaugle at 12:05 pm.






